"MGM has an extensive collection of science fiction films and television movies that appeal to a vast audience who will now be able to access that content through broadcast television."

"As a producer of some of the genre's greatest films and television series, MGM knows how passionate and loyal fans are about Sci-Fi," said Mr. Bryan.

The science fiction multi-channel network will initially debut in the fourth quarter of 2015 across approximately 30% of the country with Sinclair and MGM anticipating to enter into distribution deals with other broadcasters prior to launch. The network will feature a mix of science fiction, fantasy and adventure fan-favorite titles from MGM including television series such as "Stargate," "Poltergeist," "Outer Limits," and "Dead Like Me," among others.
