Daniels attended Washington State University before embarking on a career that has included positions at KING TV/Seattle, FOX 13/Seattle, 13 On Your Side/Grand Rapids and KIDK/Idaho Falls.

Daniels has served on the board of Sports in Schools, an organization helping under-resourced Washington State youth by increasing access and opportunities to sports in their schools, and emceed multiple philanthropic events in the Puget Sound region.

He resides with his family in the Seattle-area.
