Sinclair Petitions the FCC for Specificity in the DTV Tuner Mandate and Asks for Industry Support

BALTIMORE, Nov. 12 /PRNewswire-FirstCall/ -- Sinclair Broadcast Group, Inc. (Nasdaq: SBGI) announced today that it has filed a Petition with the Federal Communications Commission (FCC) for partial reconsideration of the recently mandated DTV tuner rule that requires the inclusion of such tuners, on a phased-in basis, in all future consumer television sets. While Sinclair applauds the Commission's efforts to enable future DTV receivers with an over the air tuner, it also believes the FCC did not go far enough to ensure that such receivers will perform well enough to meet consumers' expectations. The Petition requests that the FCC define the mandated DTV tuner in sufficient detail that would insure that consumers can "adequately" receive and view over-the-air DTV transmissions.

The rule the FCC adopted is silent on how the mandated DTV tuners must perform and Sinclair believes that the FCC has an obligation to be more specific in terms of the tuner's required performance.

In its Petition, Sinclair urges the FCC to adopt requirements for DTV sensitivity, dynamic range, selectivity, and multipath tolerance. The Petition also offers suggestions as to how the FCC can proceed to determine such values.

Sinclair's action in submitting this Petition is motivated by the recent pronouncements from leaders of the consumer electronics industry who have stated that over-the-air reception is not important to them, as well as, their actions to try and reverse the FCC's mandate in court. Additionally, Sinclair notes that the FCC has defined tuner specifications several times in the past under the All Channel Receiver Act and needs to do so again to insure the success of DTV.

Mr. Nat Ostroff, Vice President of New Technology for Sinclair stated that he invites all broadcasters to contact the FCC and join in supporting this Petition. Mr. Ostroff explains, "This Petition asks the FCC to take the necessary steps to insure that free over-the-air television survives in the digital age. I implore all broadcasters to join us in this request for specificity in the DTV tuner mandate."
